

#### PRIVACY NOTICE FOR OUR JUNIOR MEMBERS

We at the St. Sebastian Archery Club (Archery GB No. 1478).want to make sure all the personal details we hold about you are safe and secure, so we have put together this note to tell all of our junior members, how we make sure we just do that and what to do in case you have any questions for us or want to see what information we have. We are, what is known as, a data controller. This means we have control over how your details are used and who we pass them to.

Sometime organisations like ours need to appoint an individual called a "**Data Protection Officer**" to make sure that we are being very careful with your information. We don't need to have Data Protection Officer, so instead we have decided that Paul Briggs, our Club Secretary will make sure your details are safe. #### 1. WHAT TYPE OF DETAILS DO WE COLLECT FROM YOU?

We might collect the following **personal details** about you during or after your time as a member, such as:

- details of how we can contact you, such as your name, email address, where you live and phone number;
- your birthday;
- your gender;
- membership details including when you signed up to be a member and any date you decide to leave us:
- all records of when you contacted us or we contacted you on the phone or by email or when you asked us to do something;
- how you use our website and any passwords, user names and other things that may identify you to us online
- o records that tell us when you were at our events or competitions;
- o videos and photos of you (if you and your parent/guardian give us permission);
- your passport or other ID cards;
- records of whether you play at a county/national level;
- details of family members, coaches and other people we might need to contact in case of an emergency;
- o records of your ranking, grading or ratings, including any competition results, what events or competitions you have attended and how well you are performing on any development programme you are registered to;
- any disciplinary information or details of any issues you have us or we have with you;

## 2. SPECIAL CATEGORIES OF PERSONAL INFORMATION

We may also hold and use what is called "**special information**" such as your background, whether you have any religious beliefs and any information about your health such as any injuries you have/have had or times you may not have been very well. We will only use it if we have a really good reason to do so such as:

- o if it is in the interests of the public and we have a lawful reason to use it;
- o we need it to help us with a legal case we are involved in;
- o certain laws allow us to use it; or
- o you and your parent/guardian have told us you are happy for us to use it.

In the table below we refer to these as the "special reasons".

#### 3. WHERE DO WE GET THIS INFORMATION FROM?

We will normally collect personal information about you when you become a member of St. Sebastian Archers, or when you want to talk to us on the phone, by e-mail or in some other way.

In some cases we might need the information you have given us to make sure we can do what we say we are going to do with your details. Other times, we may not need it, but if we don't have it, we may not be able to provide you with the best possible service.

If you have told us we can use your information in a certain way, you can tell us to stop using it at any time, by contacting our Club Secretary, Paul Briggs (stsebastianarchers@gmail.com).

#### 5. HOW CAN YOU STOP US FROM MARKETING TO YOU?

We will only send you information regarding commercial archery products or offers if you and your parent/guardian has given permission.

## 6. WHO ELSE MAY USE YOUR DETAILS?

We may send your details to others to help us run our organisation. These are:

- Anyone you have said you and your parent/guardian are happy for us to send your details to.
- To any regional or governing body: to help us to improve and keep an eye on developments in the sport.
- The Government or our regulators: where the law tells us to do so or to help them with any investigations.
- o **Police, law enforcement and security services**: to help them with any investigation, prevention of crime or matter of national security.

#### 7. ARE YOUR DETAILS SAFE?

Your details are stored by the Club Secretary, Club Treasurer and Archery GB. Other officers of the club such as the Club Chairman, Club Captain and Venerable Persons Officer may access if required for their role. Your Club Secretary is responsible for making sure your details are stored in a safe way.

## 8. HOW LONG DO WE KEEP PERSONAL INFORMATION FOR?

We collect personal details from you for different reasons and so we might keep it for different lengths of time. For example, we might have to keep it for a long time for legal reasons, but most of the time, we will keep your details for 2 years after you last get in touch with us. It is important to make sure that the details we hold about you is accurate and up-to-date, so make sure you let us know if anything like your email address or

phone number changes. You can normally do this by contacting your Club Secretary (<u>stsebastianarchers@gmail.com</u>).

#### 9. WHAT ARE YOUR RIGHTS?

# Did you know you can ask us to do lots of things with your details?

You can ask us:

- o to tell you how your details are being used;
- o to provide you with a copy of all details we hold on you;
- to correct some of the details we hold if they are not correct or out of date like your contact details for example;
- o to delete all of the details we hold on you (unless we have a good reason not to!);
- to stop using your details in a certain way;
- o to send your details to you or another organisation e.g.: any other club you are a member of:

Some of the rights may not always apply to the personal details we hold for you as there are sometimes requirements and exemptions attached which means we need to hold on to certain information and other times the rights may not apply at all.

For some of your personal information you will be a legal, or other requirement or obligation for you to provide us with your personal information. If you do not provide us with the requested personal information we may not be able to admit you as a member or we may not be able to properly comply with legal obligations and we may have to terminate your membership.

**DON'T FORGET** though, if you have given us your consent to use your personal information in a particular manner, you have the right to tell us to stop at any time and you can always tell us to stop sending you messages we might think are of interest to you.

Please note however that telling us to stop will still let us use of the data made before you told us to stop and we may still need to hold and process the relevant personal information if required to do so. Withdrawing consent may also have the same effects as not providing the information in the first place, for example we may no longer be able to provide certain membership benefits to you.
